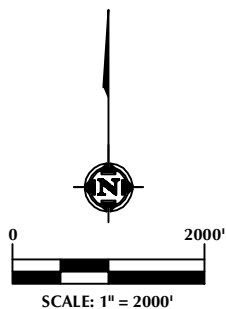

NEAREST UNIT BOUNDARY= 1077'

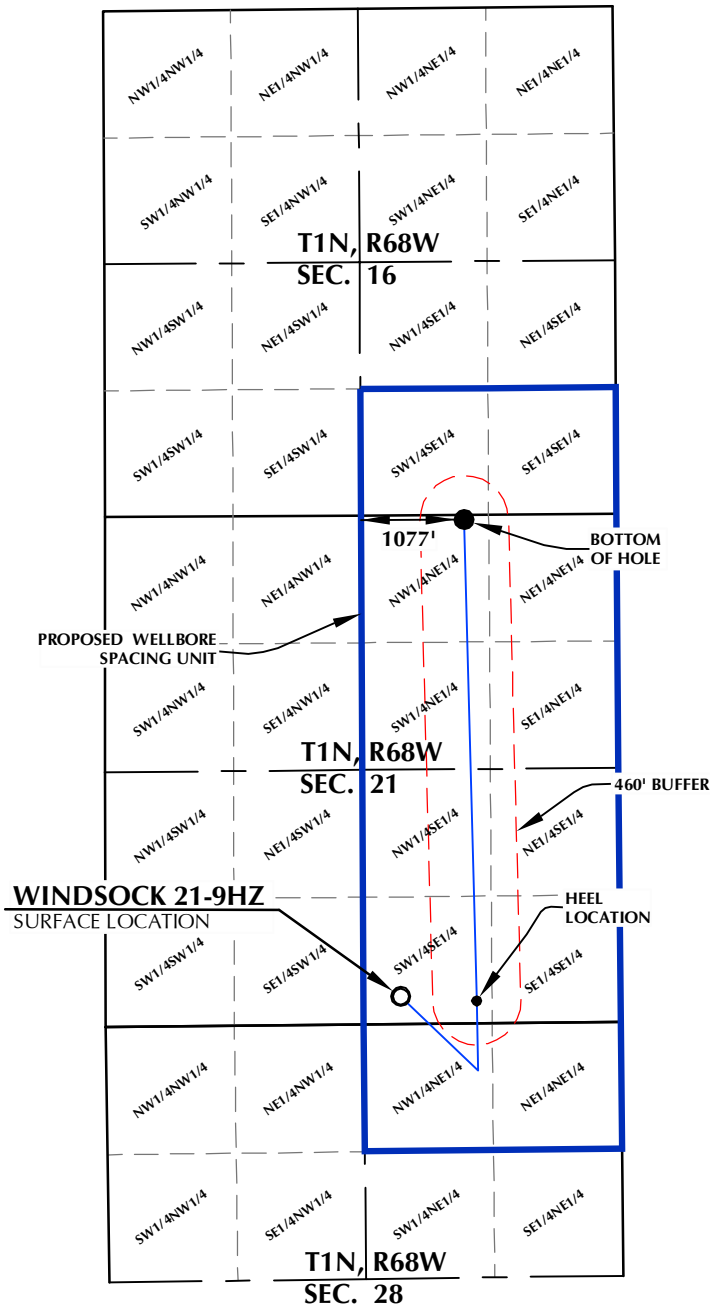
