COMMENTS:

During annual testing this well was found to have BH pressure exceeding the actionable threshold of surface casing set below 455' (doc #402137743) and a sample was taken (doc #402156411). We would like to plumb the bradenhead to a temporary tank to keep the pressure below 50 psi for a 5-week period, in hopes that it dissipates. After the blow down period we will conduct a buildup test and re-evaluate if further action is required.
