4. TIH with tubing to 1615'. RU cementing company. Mix and pump 118.5 sxs 14.8#/gal Type III cement down tubing. Cement circulate to surface (Pierre coverage from 1600'-surface).
5. Cut surface casing 6' below ground level and weld on cap.
