Wiepking-Fullerton Energy, LLC believes the remediated area has established the necessary vegetation levels required per Rule 1003 and is requesting no further action at this location. COAs have been addressed in the following manner except for COA#8:
 COA#1 - Semi-annual reclamation monitoring has been conducted each year since 2016 and monitoring reports have been submitted annually;
 COA#2 - Stormwater inspections at the Site have been conducted after rain events that have had runoff. Stormwater inspections indicate that the remediated area is stabilized, and no sediment laden runoff occurs;
 COA#3 - Weeds have been controlled with mowing and interseeding;
 COA#4 - The site has been fenced for the duration of the revegetation;
 COA#5 - All required work was completed by May 31, 2016
 COA#6 - Uniform vegetation coverage is at least 80%;
 COA#7 - Final approval from the landowner will be submitted via Form 4; and
 COA#8 - Awaiting final approval pending COGCC inspection.
