COMMENTS:

PDC would like to remediate the pressure by Commissioning a bradenhead pressure abatement system that combusts bradenhead gas via VRU system with bradenhead gas routed to a working tank to keep pressure below 50 psi threshold. This system will be commissioned within 3 months of sundry approval and in place for 6 months. At which time PDC will complete a revaluation of pressure to determine if further mitigation is required. Buildup and duration of pressure will be monitored via automation system and PDC will contact COGCC engineer if pressure increases at any time.
