At the time of permitting the Interchange B N35-20-1N, the associated anti-collision report showed Crestone Peak's Bickler 4-4-34 well (API #05-014-20648) at ~154' from the proposed wellbore so no 317.s Stimulation setback consent was required. After drill, it was discovered that the horizontal wellbore fell within 150' of Crestone's existing Kats 31-34. This sundry has been submitted to submit the signed 317.s stimulation setback consent.
