Hi, Erin,

Thanks for calling me back today to clarify Mallard's intent with the Goldeneye Center pad. Per our conversation, I will add a COA and some clarifying statements on the 2A to ensure Mallard does not unnecessarily build three separate locations (Goldeneye Center, Goldeneye East, and Duclair). We will continue processing the Goldeneye Center pad, with the understanding that Mallard is waiting for approval of the DSU in the Dec hearing (pending docket #191100661) prior to submitting APDs. At that point, Mallard will assess drilling needs and let us know your plans to either:

1. proceed with APDs on the Goldeneye Center pad (including withdrawal of pending forms on the Goldeneye East and Duclair pads, and abandonment of those approved permits/locations), or
2. proceed with the drilling of a single well from the Goldeneye East or possibly Shoveler pad to hold the sec 21 lease by production.

Please stay in touch with Doug, Penny & I on this as you further develop your plans for these locations so we can direct our work to best complement your schedule.

We are still finalizing the Goldeneye Center 2A, but I don't anticipate we will have any problems moving this forward within the required 1041 60-day clock (Nov. 25th deadline). We'll keep you in the loop as we finish this form up.
