Comment: CA from previous Inspections has not been resolved. Stormwater conditions remain the same as in previous Inspection:

Stormwater controls are insufficient. BMPs must be implemented in accordance with good engineering practices. Steep fill slopes are unstable, loose rocky material and soil is not stabilized by BMPs. Seeding, if done, was unsuccessful, and other measures are insufficient

Corrective Action: Stabilize location, fill and cut slopes, per good engineering practises. Stormwater CA Date, 10/17/16, is from Previous Inspection Doc#680100853 (6/2/16) due to activities not having been conducted.
