 Field Inspector Actions:
 On 11-11-2019, I Randy Silver area field inspector was assigned a complaint received by COGCC staff in reference to Noise. The complainant Rod Brueske stated the issues were occurring outside of complainants home.
 On 11-13-2019, I attempted to make contact with the complainant who indicated that on 11-10-19 he 2:15 AM was woken up for the second time by the loud activity. Complainant states he was working at home during the day and it was neve this loud.
 I performed a complete site inspection of the oil and gas location and associated wells in the area. At time of inspection, I did not observe any unusual noise in or around location. Myself and my supervisor Jason Gomez set up COGCC sound study equipment 350ft to the west of location. Detailed information and photos in FIR inspection doc#693501711. This will be a four-day study. Third party sound study information will be attached to complaint inspection FIR doc.
 At time of inspection, I spoke with one of the fracing supervisors and he stated at time of complaint they were fracing and no unusual activity was taking place.
 Weather conditions: clear and location wet in spots
