General Comment:

Emergency remediation of historic spill at MS-2. Spill thought to be surficial PW but oil saturation detected at 1.5 ft bgs. 170 cy petroleum contaminated soil (PCS) removed and disposed offsite at Twin Enviro Landfill, Milner CO. Heavy PCS continues to at least 5 ft bgs and to east edge of pad (possibly offsite). Irrigation ditch 100ft to east (downhill) was clear w no sheen or oil seeps observed along bank. Could not complete remediation under existing scope, schedule, budget. Snow, high winds and freezing temps forecast for Oct 10. Sloped sidewalls and bermed excavation to prevent hazard to cattle. Ranch manager (Roy) approves and say cattle are being moved to winter pasture. Email notification sent to Colton Miller and Nick Haderlie at Silver Spur Ranches. Contracted Freemont Env. 11/6/19 to assess extent of contamination and contaminated soil volumes for inclusion in Phase II remediation IFB to be conducted Spring 2020.
