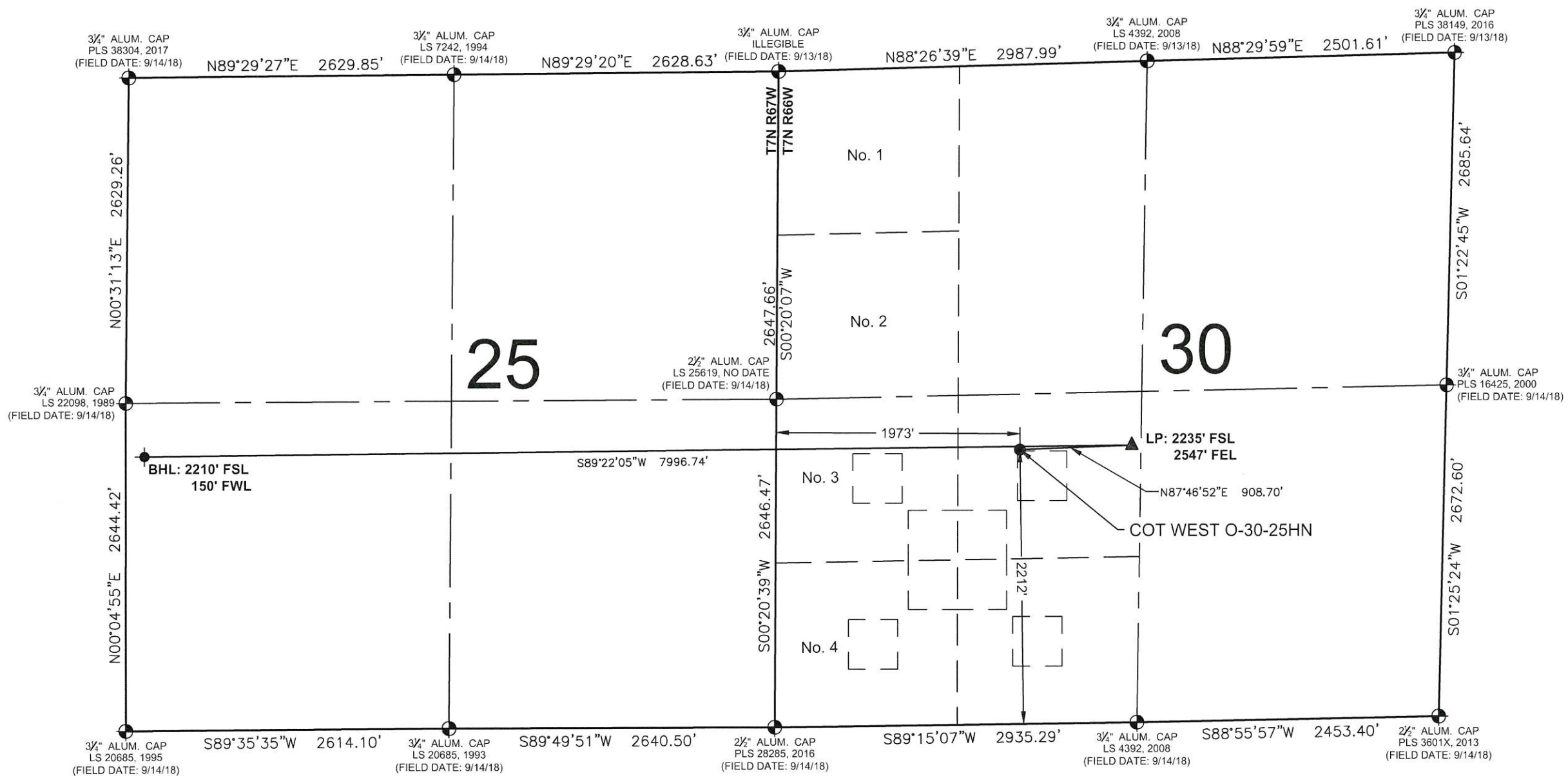


## COT WEST O-30-25HN WELL LOCATION EXHIBIT

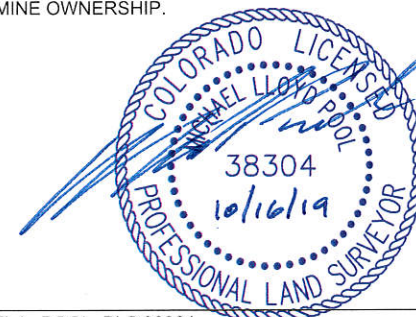


- NOTES:**

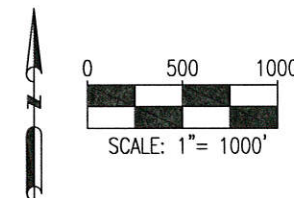
