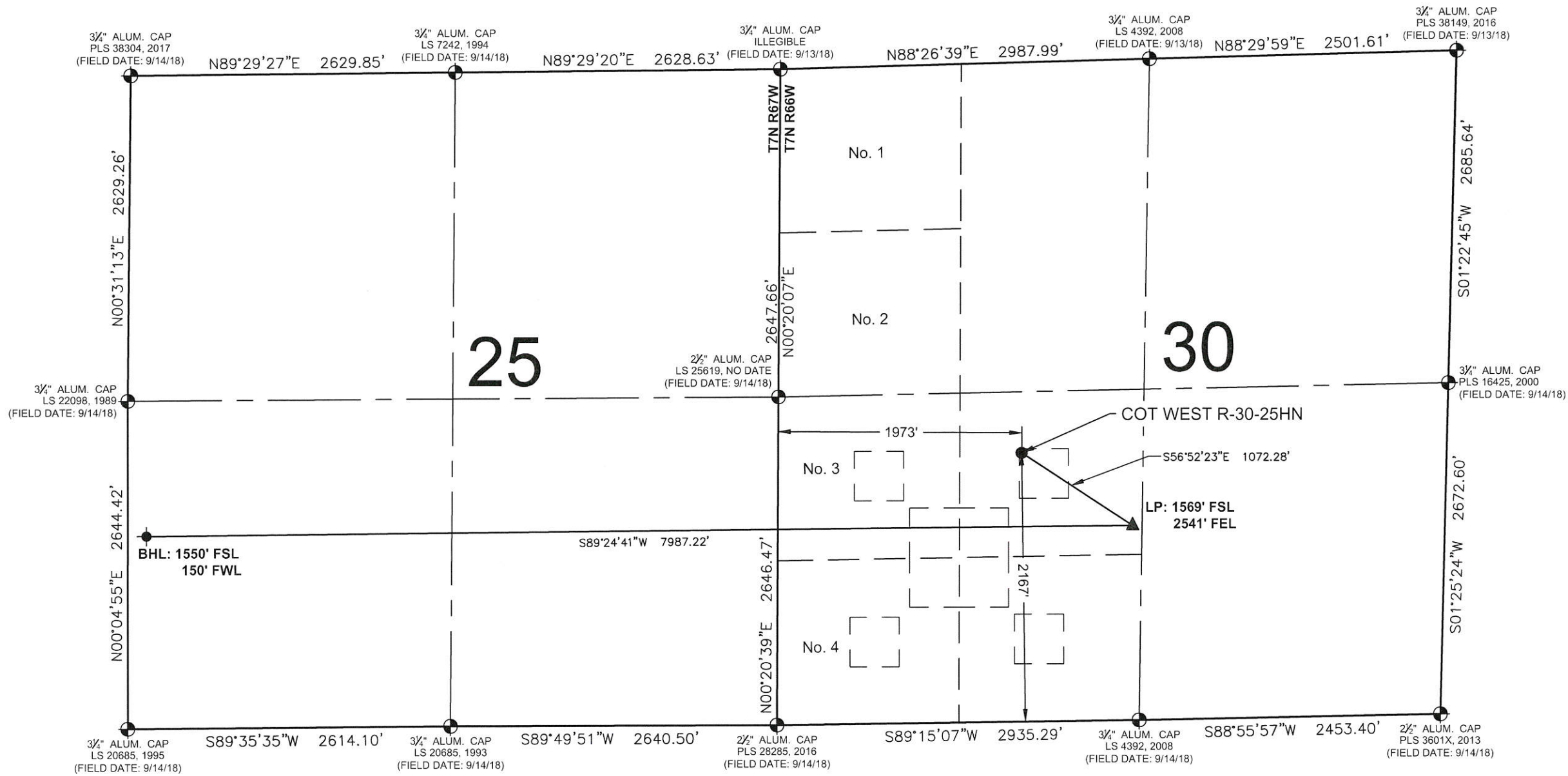


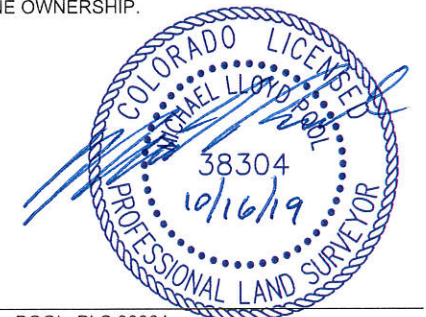
COT WEST R-30-25HN WELL LOCATION EXHIBIT

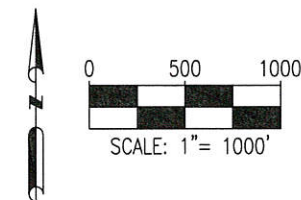
