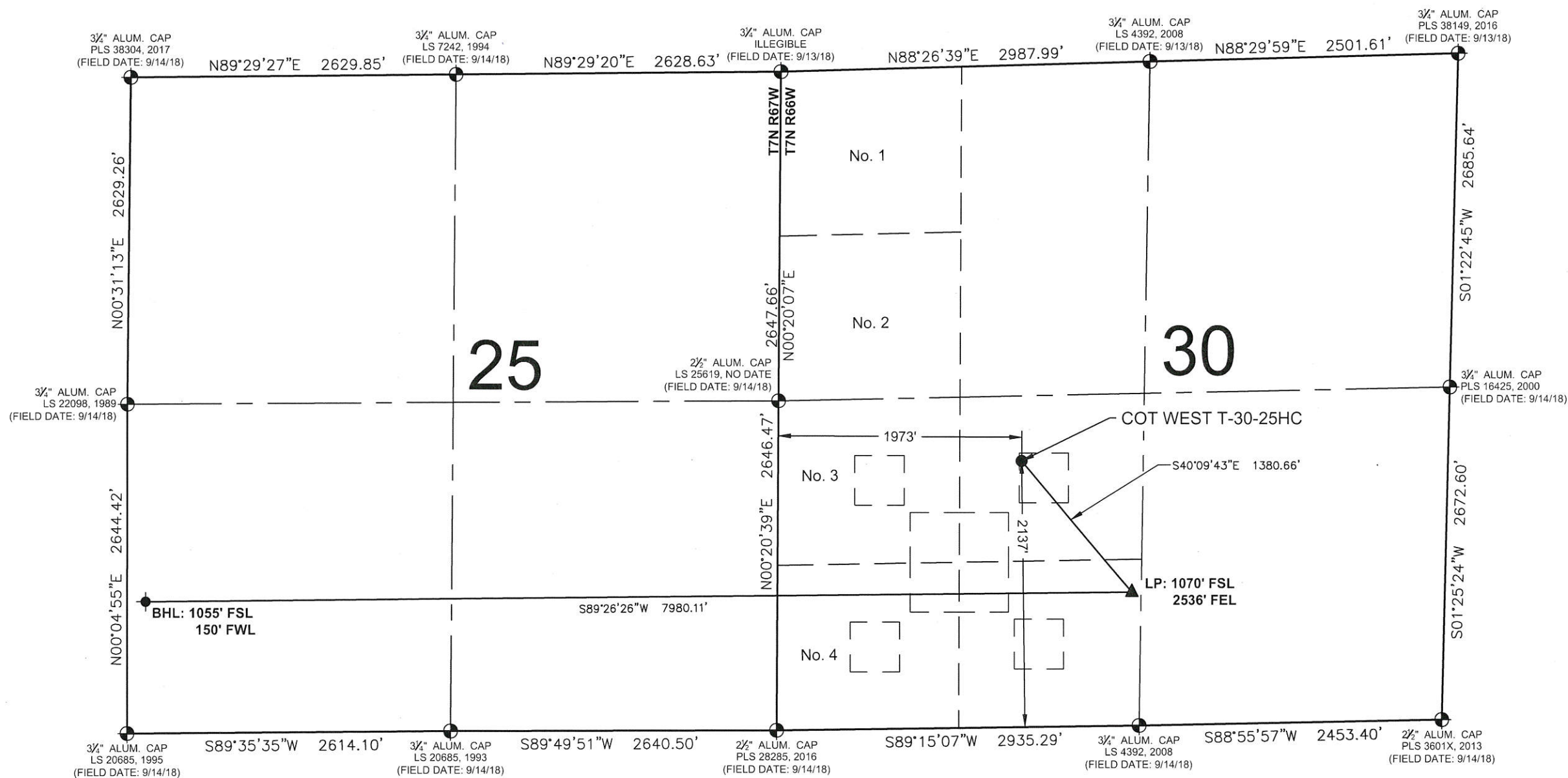


COT WEST T-30-25HC WELL LOCATION EXHIBIT

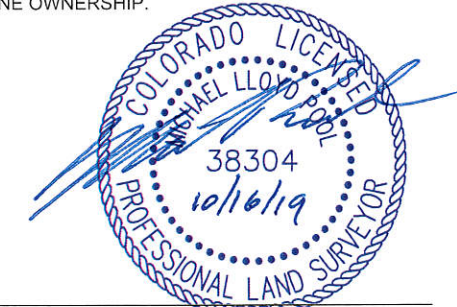


- NOTES:**

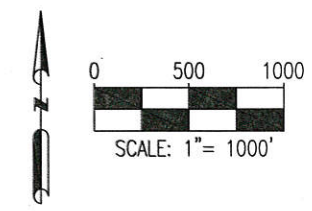
