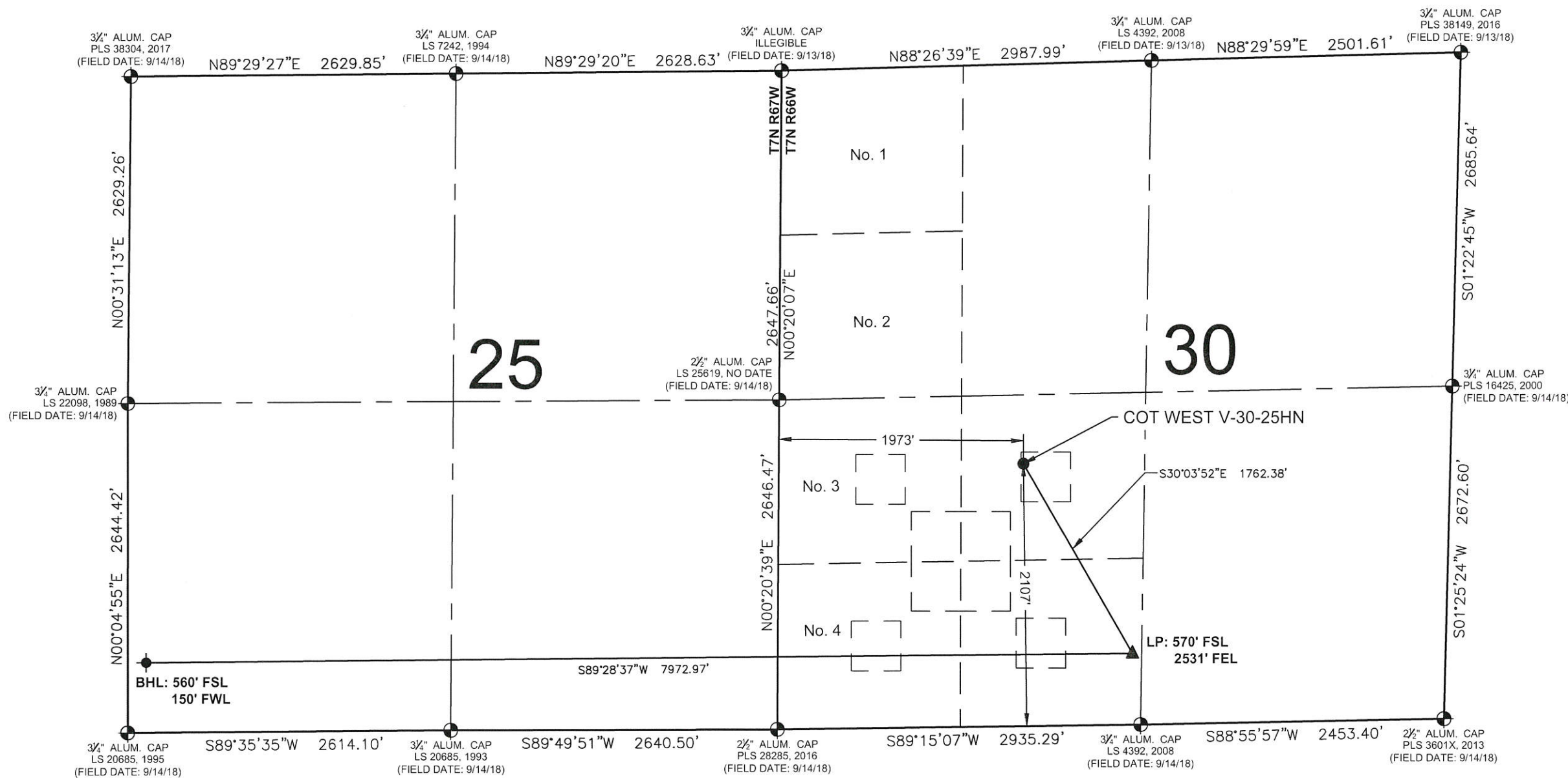


COT WEST V-30-25HN WELL LOCATION EXHIBIT

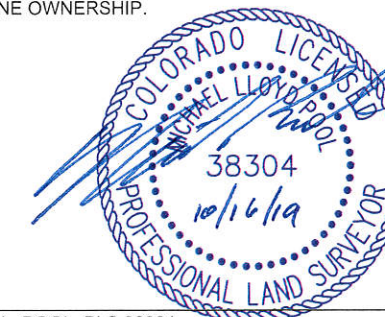


- NOTES:**

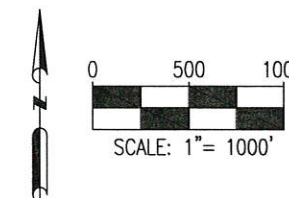
