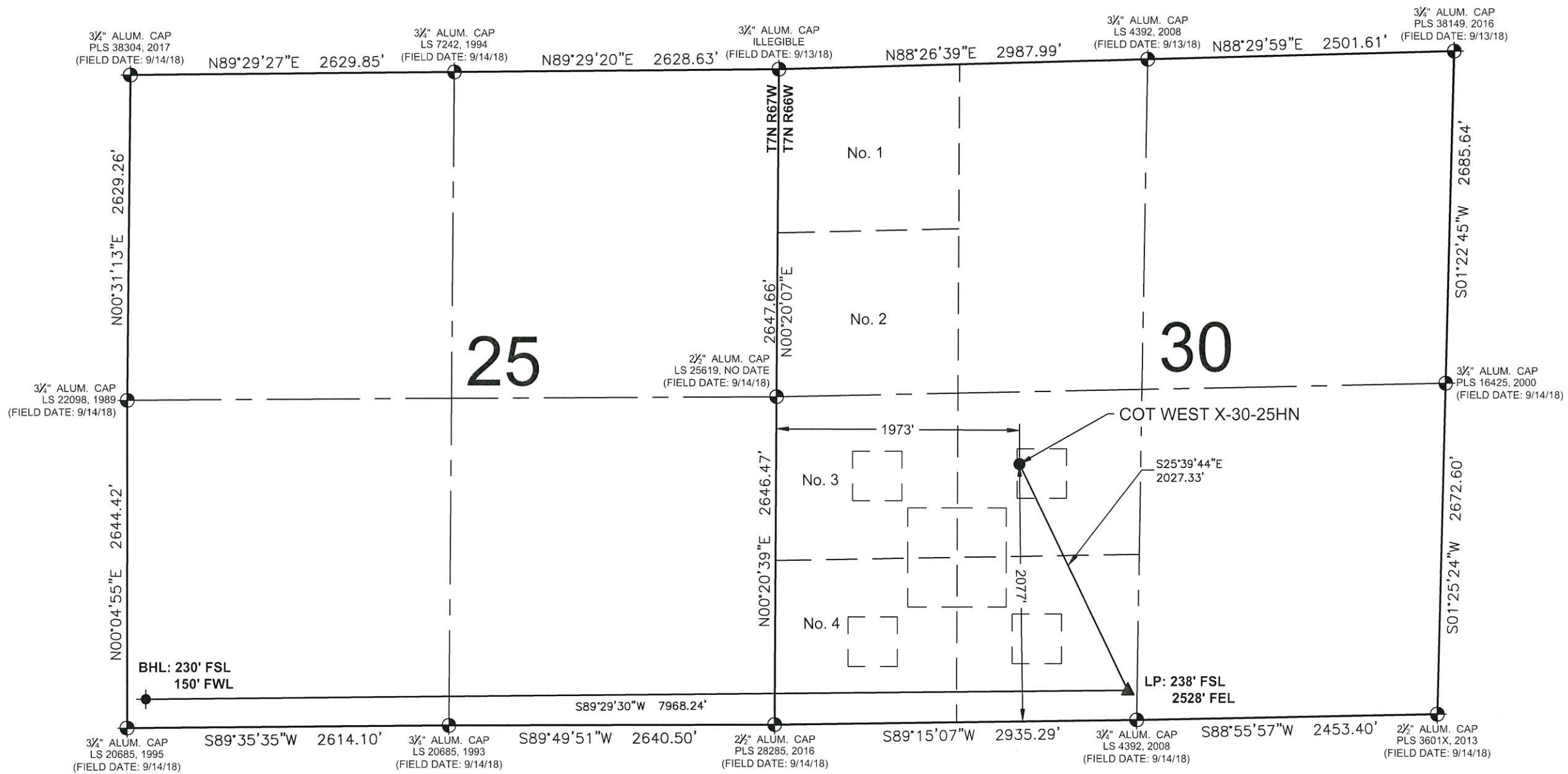


COT WEST X-30-25HN WELL LOCATION EXHIBIT

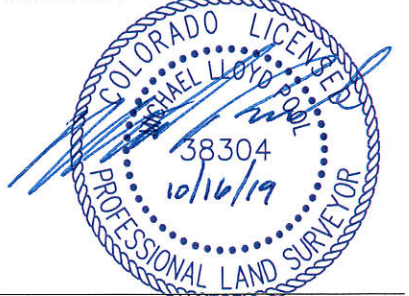


- NOTES:

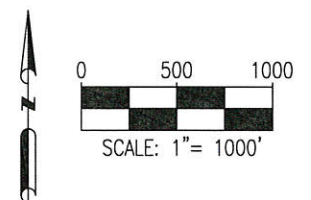
