**Re: Well Re-Entry and Mitigation
Colorado Oil and Gas Conservation Commission ("COGCC") – DJ Basin Horizontal
Offset Policy
Township 3 South, Range 66 West, of the 6th PM, SE/4 of section 25 ("Lands")**

Dear Mr. Hertel:

Per the COGCC DJ Basin Horizontal Offset Policy, any existing oil and gas wells within 1,500' of a proposed horizontal wellbore that does not have adequate protection and isolation over the treated formations must be re-entered and mitigated prior to hydraulic stimulation of the proposed horizontal wellbore. The following well(s) on your Lands do not meet the COGCC standards and must be mitigated prior to hydraulic fracturing operations:

- GRIMM #16-25 (API: 05-001-06569) (the "Well")

GMT Exploration Company LLC ("GMT") is required to enter your Lands to locate, unearth, re-enter, and mitigate these existing plugged and abandoned wells prior to hydraulic fracturing operations. This process will take approximately ten days from commencement to completion.

Please indicate your consent concerning GMT and/or its contractors or agents entering your Lands located in the City of Aurora, Adams County, Colorado to perform the above-described work to mitigate the Well by executing and returning this entire letter to GMT via electronic mail at the address below.


