Details of Plan of Work: (State names of and expected depths to objective sands. Show sizes, weights, and length of proposed casings; indicate mudding jobs, cementing points, and all other important proposed work.)

On August 17, 1955 a rotary rig was moved on the above location and the old hole was cleaned out to a total depth of 4930\* (KB). On August 20, 1955, 5 1/2" OD 14# new casing was landed at 4930\* (KB) with 100 sacks of cement. The cement was allowed to set for 36 hours at which time the casing was perforated from 4884\* to 4887\* with 8 holes per foot. A packer was then run on 2 1/2" EUE tubing and set at 4864\*. The mud was swabbed from the tubing. This well flowed gas at a 2,900 MCF rate on 8-23-55. The packer was pulled out of the well and the tubing was landed at 4895\* (KB). The drilling mud was displaced with water, and the water swabbed from the hole. This well is shut in at the present time.
