While there, I observed SI wellsite. This is a follow up inspection per Doc. #699300262 During this inspection the following possible compliance issue appears to have been addressed:

Mechanical Issue: WH packing leaking around tubing appears to have been tightened.

Venting or Flaring Natural Gas: Gas is no longer being vented from well.

Location is dry, weather is clear

No follow up on this site inspection needs to be conducted it appears that the compliance issues have been addressed to comply with COGCC Rules.
