 Field Inspector Actions:  
 On 11-17-2019, I Randy Silver area field inspector was assigned a complaint received by COGCC staff in reference to Noise. The complainant Amanda Harper 517 County Road 18 Longmont CO stated the issues were occurring outside of complainants home.  
 On 11-19-2019, I attempted to make contact with the complainant who indicated that on 11-12-19 she was woken by a loud grinding jet engine sound from Regnier well site during the Flow back phase. She also stated the violated the sound rule for sound over a certain decibel stopping after 10 min.  
 I performed a complete site inspection of the oil and gas location and associated wells in the area. At time of inspection, I did not smell any unusual Noise. Regnier farms is currently in the fracing stage not Flow back. Sound rule states (noise levels may be increased ten (10) dB (A) for a period not to exceed fifteen (15) minutes in any one (1) hour period). Third party sound study information is attached to complaint inspection.  
 At time of inspection, I spoke with fracing supervisor he stated at time of complaint they were fracing and no unusual activity was taking place. Also after speaking with supervisors, one crew rigged out on 11-17-19, 2nd crew should be done on 11-20-19 and last crew should be completed on 11-24-19 if ever thing goes as scheduled.  
 Weather conditions: Cloudy and location dry

 No violation of COGCC rules were observed at the time of the inspection.
