Comment: Erosional rilling and scouring are observed on the well pad cut and fill slopes with little vegetative cover.

Corrective Action: Stormwater controls (ie BMPs) and erosion controls (ie mulching, blanketing) need to be installed to stabilize erosion within the project area. These controls need to be selected, sized, installed, and maintained in accordance with good engineering practices and until location is stabilized with desirable perennial vegetation.
