## INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

This form has been prepared to provide prior notice of the closure of a partially buried produced water vessel (vessel) at the Lucky L 9-25 facility. In accordance with COGCC Rule 905.b., soil samples and a groundwater sample (if present) will be collected following removal of the vessel to determine if soil and groundwater (if present) meet the concentrations levels of COGCC Table 910-1. Field screening of soils will be conducted during vessel removal activities.

## PROPOSED SAMPLING PLAN

### Proposed Soil Sampling

Will soil samples be collected as part of this investigation? ( Number, type (grab/composite), analyses, and locations of samples ):

Following the removal of the vessel, discrete grab soil samples will be collected from the sidewalls and base of the excavation. The soil samples will be field screened for total volatile organic compounds using a photoionization detector (PID). The base soil sample will be submitted for laboratory analysis of benzene, toluene, ethylbenzene, and total xylenes (BTEX), naphthalene, and total petroleum hydrocarbons (TPH)-gasoline range organics (GRO) by United States Environmental Protection Agency (USEPA) Method 8260C, TPH-diesel range organics (DRO) and oil range organics (ORO) by USEPA Method 8015C, pH by USEPA Method 9045D, specific conductance (EC) by USEPA Method 9050A, and sodium adsorption ratio (SAR) by USDA Agricultural Handbook 60 Method 20B. The sidewall soil samples will be submitted for laboratory analysis of BTEX, naphthalene, and TPH.

### Proposed Groundwater Sampling

If groundwater is encountered during vessel removal activities, a minimum of one grab sample will be collected as soon as practical following removal of the vessel and submitted for laboratory analysis of BTEX by USEPA Method 8260.
