Desirable perennial vegetation is establishing, though snow cover prevented detailed assessment. Stands of desiccated Canada & Russian thistle were noted on site. It does not appear that weed control was implemented this year. Weed monitoring & control program need to continue until site passes Final Reclamation. Refer to Photo Log attached.
