Gentlemen:

Attached please find our APD, surveyor's plat and our check for the filing fee on the captioned well.

As stated on the APD, the lease where our well will bottom is zoned mountain residential, and CZAR can't drill on the surface. For this reason, the surface location has been moved just east of the Elkins lease on surface that is owned by a Mr. James B. Thompson. Agreements between CZAR and Mr. Thompson pertaining to surface damages and surface leasing have already been signed.

This well will be directionally drilled not only because of the surface access problems, but also because it will increase the chances of intersecting more fractures in the objective formation, and this will increase the probability of encountering production.


