<p>COGCC Inspection Report Summary</p> <p>On Monday 11/25/2019 at approximately 1200 hrs. I, Inspector Robbie Revas, Conducted an on-site inspection at the Shoe #1KP Kauffman, at API # 05-123-05061 in Weld County Colorado.</p> <p>While there, I observed SI well and Tank battery. This is a follow up inspection per Doc. # 699300568</p> <p>During this inspection the following possible compliance issues were observed and are now delinquent:</p> <p>Rule 603.f Housekeeping: Dead weeds on access road, and throughout well site location. CA date 11/21/2019 see attaches photos #3, 4, and 5.</p> <p>605.d Mechanical conditions and 912.b Gas being vented or flared during non-upset condition: Wellhead appears to be venting around the threads to atmosphere. Securely fasten all valves,</p> <p>pipes and fittings to ensure good mechanical conditions inspect at regular intervals and maintain. 30 days unless leak is found then 24 hrs. To repair or isolate the leak. CA date 11/15/2019 See attached video.</p> <p>The following possible compliance issue is still within corrective action date and not considered delinquent.</p> <p>WH sign and TB sign still show Highpoint Resources and their emergency number. The form 10 was submitted on 5/1/2019 Doc. # 402018972 and is in process KP Kauffman should replace signs</p> <p>immediately so proper information is at wellsite See attached photo #1 and 2.</p> <p>Location is dry, weather is cloudy.</p> <p>At approximately 1210 hrs I spoke with Chris Ellis with KP Kauffman I explained that this is the second call about the WH venting gas around the threads and it is delinquent and according to COGCC Rule 912.b. he said he was going to send his operator that is in the area to take care of it. This inspection is being submitted to enforcement due to compliance issues not being addressed. At approximately 1315 hrs Chris Ellis called me back and said that his crew had made it out to the wellsite and fixed the venting issue.
