We will add two feet of clean soil to the bottom of the pit (see sourcing below). We will use the backhoe to blend the clean soil in with the bottom of the pit. Then the pit will be backfilled with remaining clean soil. Clean soil source: If backberrn of pit exists, this material will be utilized to backfill pit. Native fill material may be collected from the recontouring of cut and fill slopes. Clean fill material will be brought onsite, if needed.
