INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A partially buried produced water vessel (PWV) was removed from the RITCHEY USX WW27-04 location on September 27, 2019. Groundwater and impacted soil were not encountered in the PWV excavation. A liner was not present beneath the PWV at this site. The PWV at this facility has been permanently removed. Soil samples from the excavation were submitted for laboratory analysis, to determine if a release occurred. The general site layout, soil sample locations, and PWV excavation dimensions are depicted on the Excavation Site Map provided as Figure 1.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

On September 27, 2019, following removal of the PWV, soil samples were collected from the base and sidewalls of the excavation. The samples were field-screened for volatile organic compounds using a photoionization detector. Soil samples B01@5', N01@4', E01@4', S01@4', and W01@4' were submitted for laboratory analysis of benzene, toluene, ethylbenzene, and total xylenes (BTEX), total petroleum hydrocarbons (TPH), and naphthalene. Base soil sample B01@5' was also analyzed for pH, specific conductance (EC), and sodium adsorption ratio (SAR). Results for all soil samples indicate that BTEX, TPH, naphthalene, EC, and SAR concentrations were compliant with COGCC Table 910-1 allowable levels. Results for sample B01@5' indicated that pH exceeded the COGCC Table 910-1 allowable level. However, this sample was collected greater than 3 feet below ground surface; therefore, no further excavation was required. The analytical results are summarized in Table 1, and the laboratory report is attached.

Laboratory results indicate that all soil samples were in full compliance with COGCC Table 910-1 allowable levels with the exception of pH in sample B01@5', which was collected below the root zone (greater than 3 feet below ground surface); therefore, no soils were removed. The excavation area was backfilled and contoured to match pre-existing site conditions.

REMEDIATION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Laboratory results indicate that all soil sample concentrations and levels were in compliance with COGCC allowable levels with the exception of pH in sample B01@5', which was collected below the root zone. Groundwater was not encountered in the PWV excavation. Based on the analytical data presented herein, assessment is complete at this site and no further activities are required. This supplemental Form 27 has been prepared to request a No Further Action (NFA) determination for this site.
