**General Comment:**

Preconstruction Inspection

Construction contractor asked if the location could be looked at prior to beginning construction because of it being in a swale (see attached photos). Inspector contacted COGCC's OGLA Supervisor to see if the location could be moved or what needed to be done. COGCC's OGLA Supervisor said that he would talk with the COGCC's OGLA for that location. The Inspector would call back after going to location. Inspector verified GPS of stake with GPS on Form 2A. The swale is in a dry land crop field (winter wheat) with the well stake being on the hill to the west side of the swale. Contractor and Inspector talked with COGCC's OGLA while they were on location and it was decided by the OGLA that the location did not need to be moved as long as BMPs were placed to prevent sediment transport to the Arikaree. Moving the location approximately 50' to the west would put it over the top of the hill and into the next drainage. It would have required much more footage to move the location east and out of the bottom of the swale. Contractor will install surface roughening, compacted berms, and a dike on top of the side of the location that the swale is on and the OGLA agreed.
