INSTRUCTIONS

Notice must be given to the Director, and approval obtained in advance of the time when the owner or operator expects to recomplate or abandon a well or to change plans. Within thirty (30) days after recompletion, change of plans, or remedial work, a detailed report of the work done and the results obtained shall be submitted on this form in duplicate for wells on Patented and Federal lands, and in triplicate for wells on State lands. In work that affects only rods, pumps or tubing or other routine work such as, but not limited to, cleaning out to previous total depth, no report is necessary.

(DETAILS OF WORK)

Ran 2" Tubing in hole with Baker RT-8 squeeze Tool. Set Packer at 4849'KB and broke formation with 10 barrels oil at 2500 PSI which decreased to 200 PSI. Mixed 50 sax cement and displaced to formation, pulled Packer, Drilled out soft cement and Bridge Plug and cleaned out to bottom. Ran Baker EEJ Packer on 2" Tubing, set at 4920'KB, broke formation with 32 barrels oil at 4500 to 3700 PSI, fracture treated "J" sand with 6800# sand mixed with 8000 gallons oil. Mixture to formation under 4500 to 4000 PSI at rate of 5.4 barrels per minute. Pulled Packer and cleaned out to bottom. Swabbed load oil and cleaned out to bottom. Placed well on production. The well is now producing 3.3 barrels oil and 15.7 barrels water with gas volume of 7.7 MCF/D. Well was temporarily abandoned prior to workover.
