11-18-85	0 hours	Rigged up power tongs. Pulled tubing.
11-19-85	10 hours	Dug cellar. Welded on collar. Rigged up jacks. Ran sand from 5111' to 5000'. Loaded hole with water. Set 5 sacks cement on sand. Water truck, 5 hours.
11-20-85	9 hours	Worked pipe to 34". Ran shots to 4200' and 4000'. Worked pipe.
11-21-85	6 hours	Worked pipe. Pumped 50 bbls. water. Worked pipe loose. Pulled 20 joints. Water truck, 5 hours. pump job.
