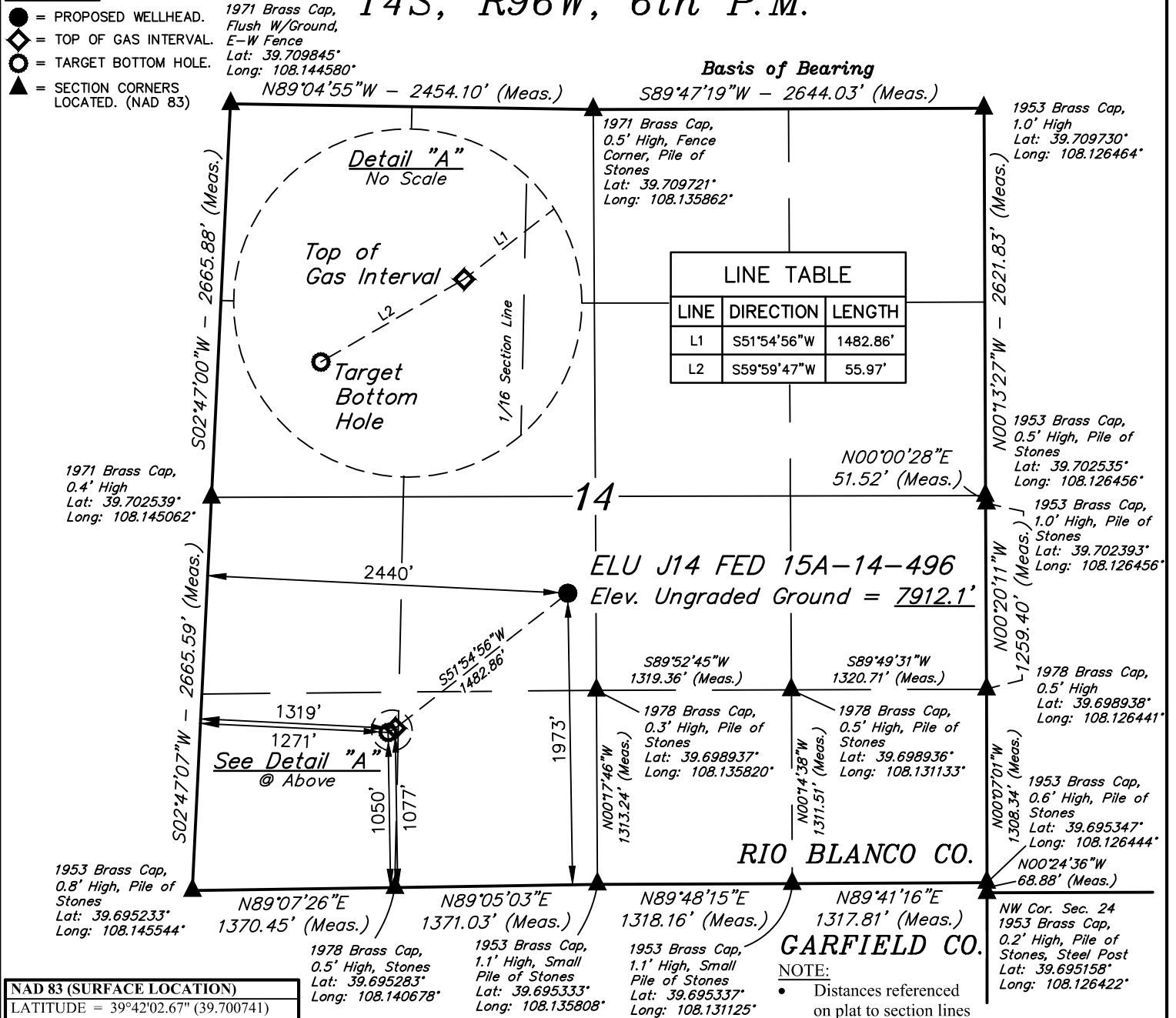


LEGEND:
