 On 12-06-2019, I Randy Silver area field inspector was assigned a complaint received by COGCC staff in reference to Noise. The complainant Tammy Raichle 3395 Yale Drive Broomfield CO stated the issues were occurring outside of complainants home.  
 On 12-9-19-2019, I attempted to make contact with the complainant who indicated that on 12-05-19 she experienced a loud noise coming from the fracking site near her. It sounds like a humming engine. It gets louder and louder then slowly fades away then repeats. I explained the fracing process to her.  
 I performed a complete site inspection of the oil and gas location and associated wells in the area. At time of inspection, I did not observe any unusual noise in or around location. After reviewing third party sound study data, location is with in compliance per COGCC rules. Sound study data will be attached to compliant inspection form.  
 At time of inspection, I spoke with fracing supervisor he stated at time of complaint they were fracing and no unusual activity was taking place. This is Liberty Oil Field Services Tier 4 Quiet fleet.
