Well was shut-in for horizontal safety prep. RBPs set at 8040' with 2 sacks of sand and 7100' with 2 sacks of sand on top. PRESSURE TEST CASING AND RBPs TO 500 PSI. Good tests. Pressure test information is included with the Operations Summary Report submitted with the Form 5A on 1/8/2019. TA status is provided via down-hole plug and surface isolation provided via closed master valve. This well has been evaluated and is on our schedule to plug and abandon in Q1 2021.
