**General Comment:****COGCC Inspection Report Summary**

On Friday 12/13/19 at approximately 11:30 AM, I, Inspector Scott Ramsey, conducted a routine inspection at Caerus G7E, at Location # 323925 in Garfield County, Colorado.

When I arrived on location I smelled a strong odor of gas upon further investigation I found a 2 inch line that is after the meter house that is venting gas and fluid. The ball valve seemed to be shut but the cap is missing where it is venting.

See photos of compliance issues.

Scott Mueller with Caerus came to location to observe release. I also contacted COGCC environmental and informed them of the situation. Scott Mueller contacted Summit midstream because the valve is on the back side of the meter house, he informed me that the meter house is and anything after it belongs to Summit midstream and he is not allowed to do anything with it. Two Summit Midstream employees showed up and put a blind flange on and also adjusted the ball valve to isolate the release.
