Comment:

This location required a reinspection after two passed inspections. Several rows of winter wheat were checked (see attached photos) and growing like the rest of the field. There is a small swale (since 2003 PA) that may have caused the concern in the last inspection but looking closely at the current crop and the rest of the field, there are no effects as it is just a swale and swales occur in other places in the field. The electric pole and access road are currently in use for the producing well to the south. Transect was not done as this is an annual crop field and not perennial forage.
