- 4) Perforate at 1550' 60 sx
- 5) Set packer at 1450' 1550' Perf
- 6) Circulate and pump 60 sx into perfs
- 7) Let cement cure & pressure test squeeze
- 8) Run CBL from 2000' to surface
- 9) Retrieve RBP
