Rule 604.c.(2)M Housekeeping: Angle iron fence around PU is missing a pole and is in disrepair. CA date 11/22/2019 see photos 4 & 5.

Rule 210.e Signs: WH sign is faded and emergency number is not legible and needs to be replaced. CA date 12/7/2019 see photos #1 and 2.
