The inspection includes: "Compressor and associated equipment and flowlines to include: knockout scrubber, exhaust manifold, muffler, and PBV blowdown drum are all disconnected from process and blinded and are not in use and are unused equipment. Compressor is currently bypassed with LOTO on suction/discharge valves. Corrective Action: Remove unused equipment or put back in service per Rule 603.f."

The compressor is large and heavy to transport. Once winter is over and the compressor can be safely moved without impacting roads etc. it will be moved to another location and put into service.
