COMMENTS:

See attached Form 4 - The bradenhead test completed on April 30th, 2019 exceeded the threshold pressure for a critical area (5 psi) with a surface casing pressure of 9 psi (test form attached). The previous bradenhead test from 7/20/2017 observed a bradenhead pressure of 0 psi. The surface casing pressure diminished to a whisper in 15 seconds and to no flow in 1 minute and 45 seconds through a 3/4" needle valve. Gas samples were taken that revealed the surface casing and the produced gases are dissimilar (gas analyses attached). The methane mole percentage in the produced gas is 87% with approximately 7% carbon dioxide and 6% nitrogen. The methane mole percentage in the surface casing gas is 54% with approximately 0% carbon dioxide and 46% nitrogen. The produced gas has significantly higher concentrations of both methane end carbon dioxide. These compositional differences suggest that the surface casing gas is coming from a different source than the production gas. Since the bradenhead pressure of this well exceeds the threshold pressure at 5 psi and rapidly bleeds to a whisper and then to no flow, Red Willow proposes leaving the bradenhead shut in and re-evaluating the well in another two years.
