COMMENTS:

Bonanza Creek respectfully requests continued TA status. The Antelope 24-20 was plugged back with CIBP @ 6249' with 2 sacks of cement on 5/18/2019. Form 5A to report TA status of Nio/Codell was submitted 6/13/2019 (Doc # 402065046); the well was SI and plugged back due to offset HZ frac of Bonanza Creek's Antelope J-20 Pad. The well is closed to the atmosphere via valve locked out and tagged out at the master valve, and the a "Temporary SI for HZ prep" sign is attached to the master valve. Pressure was tested on 5/18/2019, pressure held to 1000 psi and held for 10 minutes (Operations Summary attached to sundry). Bonanza Creek has this well on their future 2020 P&A Schedule, therefore are requesting continued TA status until such time as this well is P&A'd an annual TA sundry notice will be submitted in 2nd quarter 2020 to update the COGCC on the status of P&A plan.
