This well was shut-in for horizontal safety prep. RBPs were set at 7170' and 7078' with 2 sacks of sand on each plug. Pressure tested casing and RBP at 7170' to 1000 psi for 15 minutes on 3/9/19. Test good. Pressure information was submitted with Form 5A on 4/4/19. TA status provided via down-hole plug and surface isolation provided by closed master valve. This well has been evaluated and scheduled for P&A in approximately Q4, 2020.
