#### COMMENTS:

Bonanza Creek respectfully requests continued TA status. The Antelope14-17 was plugged back with CIBP @ 6287' with 2 sacks of cement on 8/27/2019. Form 5A to report TA status of Nio/Codell was submitted 09/23/2019 (Doc # 402167286); the well was SI and plugged back due to offset HZ frac of Bonanza Creek's Antelope J-20 pad. The well is closed to the atmosphere via valve locked out and tagged out at the master valve, and the a "Temporary SI for HZ prep" sign is attached to the master valve. Well pressure tested 1000#, held pressure for 10 minutes, test was good. Bonanza Creek has this well on their 2020-2021 P&A Planned Budget Schedule, therefore are requesting continued TA status until such time as this well is P&A'd. An annual TA sundry notice will be submitted in 3rd Quarter 2020 to update the COGCC on the P&A plans of this well.
