**Comment:** Operator has not installed any additional vehicle tracking device BMPs to access road since the previous inspection. As the previous inspection noted, the current vehicle tracking device BMPs were not adequate and remain inadequate. Track out was observed approximately 500 feet westbound on County Road 2 from the entrance of the location. Refer to the attached inspection photos.

**Corrective Action:** Maintain vehicle tracking BMPs on the oil and gas location to comply with rule 1002.f.(2)F. Material is tracked onto County Road 2 and Operator shall clean material tracked onto the county road. Operator shall contact the appropriate authority to perform clean up on the county road.
