Upon receipt of FIR #689703887, TEP employees Mike Gardner and Kyle Kohl spoke with COGCC EPS staff Alex Fischer and John Heil on 12/16/19 to discuss COGCC MLVT policy document dated June 13, 2014. COGCC EPS staff reminded TEP that per the MLVT policy, use of such tanks for water storage must be permitted through either a Form 2A or Form 4. The three MLVTs at the GM 41-1 frac pad have since been dismantled and are being removed from location. TEP explained that we would like to use these tanks during upcoming completions work, and we understand that per the COGCC MLVT policy, we will need to request permission pursuant to a Rule 502.b variance request OR a waste management plan under Rule 907.a.(3).

TEP understands and agrees with this direction from COGCC EPS staff and will provide a request prior to using MLVTs at future locations. In addition to providing appropriate notice to COGCC, TEP will prepare a detailed Waste Management Plan, and a summary of the specific details outlined in the MLVT policy document (e.g., design criteria for the specific tanks that will be used; site preparation and installation, MLVT operations and contingency planning, etc.). All information will be submitted to COGCC for review and approval on the appropriate Form 2A or Form 4.
