Comment: Although the Operator has performed Final Reclamation activities the Operator failed to properly contour the access road west of the tank battery. Access road west of TB is within cropland, currently winter wheat. There was some germination of desirable species throughout portions of the rangeland area (tank battery, access road north of TB and well location); however, appears much of the germination has been grazed. Currently, there are high densities of Russian thistle and Kochia, which is not reflective of reference areas.

Corrective Action:	Comply with Rule 1004. Since disturbance areas not in compliance are within cropland, Operator shall collaborate with the landowner to determine mitigating measures that will allow reclamation work to be conducted in such a manner as to not interfere with agricultural activities or crop production.
