Comment

It appears areas of Location require installation of Interim Reclamation; at the least, on the unstable Cut slope. Senesced remains of Thistle (B List Noxious weeds) were identified on site as in 2010 Insp and evidence of Houndstongue noted. Site will need to be visited out of snow cover to assess make up/extent of desirable vegetation and if need for additional areas to be reclaimed.

Corrective Action

Reclaim and revegetate any areas no longer needed for use, incorporating with Stormwater CA to Stabilize Cut slope. Control Noxious weeds in growing season 2020.

Comment: Cut slope is steep and has no erosion control BMPs in place and a 20' wide headwall gully has developed. Root systems at top of Cut are being undercut and exposed. Materials, sediment and sizable rocks/boulders are migrating downslope and even incurring into and damaging fence panels protecting equipment.

Corrective Action: Stabilize Cut slope, Installing /repairing required BMPs per Rule 1002.f.
