Dear Mr. and Mrs. Sherman:

Reference is made to that certain Oil and Gas Lease dated July 10, 1989 between Joseph H. Sherman and Wynona Sherman, as Lessor, and Edward A. Watlington, as Lessee, covering the E/2SE/4 of Section 27 and W/2NE/4, N/2NW/4 of Section 34, T7N-R91W, Moffat County, Colorado. This lease was bought by Mr. Watlington for Ernest H. Cockrell.

Mr. Cockrell and others now wish to drill a well at a location approximately 655 feet from the North line and 1,151 feet from the east line of Section 34. Although the well is not on your property, it is approximately 169 feet from your property and requires your consent if we spud our well prior to obtaining spacing rules. We have a hearing set for June 18, 1990 with the Oil and Gas Conservation Commission to act on our request for 320 acre spacing. The hearing involves all of Sections 27, 34 and other sections. The 320 acre spacing is consistent with spacing rules established in adjacent sections. We anticipate we would establish the north one half of Section 34 as the spacing unit for the above mentioned well.




