 - @ 47 PR Wells
 - 9 DG status
 - ◆ March 2019 no rig
 - ◆ Wells from 2016 still in DG status
 - 39 Locations (*1.5 wells per location*)
- Climate
 - 7,800 to 12,957 feet elevation
 - 89 inches snow (average)
 - 14 inches average rain
 - Average days with precipitation 107




Sensitive Area

- Wildlife (*moose viewing capital of the world*)
- Sage grouse
- Surface water
 - Headwaters of the North Platte
 - Jurisdictional Wetlands
 - Irrigation Ditches
 - Creeks & streams
- Groundwater
 - Variable based on season
 - Near surface during spring runoff and snow melt
- Wilderness Areas on both sides

Inspections

- July 1, 2017 to July 1, 2019
 - 230 Inspections
 - 336 corrective actions
 - ◆ 14 Field Inspection Report Resolutions in response to CA
 - ◆ 50 (of 336) issued with past due date
 - ◆ 88 CA currently



- 8 open remediation projects


