## WELL ABANDONMENT REPORT

This form is to be submitted as an Intent to Abandon whenever an abandonment is planned on a borehole. After the abandonment is complete, this form shall again be submitted as a Subsequent Report of the actual work completed. The approved intent shall be valid for six months after the approval date, after that period, a new intent will be required. Attachments required with the Intent to Abandon are wellbore diagrams of the current configuration and the proposed configuration with plugs set.

A Subsequent Report of Abandonment shall indicate the actual work completed. Attachments required with a Subsequent Report are a wellbore diagram showing plugs that were set and casing remaining in the hole, the job summaries from all plugging contractors used, including wireline and cementing (third party verification) and any logs that may have been run during abandonment.

#### Technical Detail/Comments:

This location does not meet reclamation requirements. Well casing remains on location and has not been cut below grade. Scope of work is to ensure cement coverage to surface, cut 4' below grade, and cap well. If there is no cement from 50' to surface, 20 sx cement will be used to ensure cement coverage over that distance.

NuWave's process is superior to conventional methods, providing competitive abandonment costs for stakeholders, minimal environmental disturbance, and increased overall operational safety.

- Tool deploys into the production casing with the well bores being cut from the inside to the outer casings
- No open flame, fire hazard or hot work permit required
- No confined space requirements
- Minimal soil disturbance
- Eliminates sink holes and depressions on lease
- Expediates re-vegetation
