**General Comment:**

On January 6th, 2020, Reclamation Specialist Trujillo conducted a Final reclamation and stormwater inspection at D & D Resources Inc,'s Emerald 230 Location in Rio Blanco County, Colorado.

The following alleged compliance issues were observed during this inspection:

1004.a: It was observed that Location does not appear to have been recontoured or regraded. An open pit evident on the south end of the Location

1002.f: Stormwater erosion degradation evident on the cut slopes of the Location.

Any corrective action(s) from previous inspections that have not been addressed are still applicable.
