 On 1-3-2020, I Randy Silver area field inspector was assigned a complaint received by COGCC staff in reference to Odor. The complainant John Mavaro 4711 Wilson Drive Broomfield CO stated the issues were occurring outside of complainants home.
 On 1-8-2020, I attempted to make contact with the complainant who indicated that on 1-3-2020 experienced a low frequency drone noise at night. Complainants residents is approximately 3300ft NW of the Livingston pad.
 I performed a complete site inspection of the oil and gas location and associated wells in the area. At time of inspection, I did not observe any unusual noise in or around location. Third party sound data was requested and location appears to be in compliance at time of complaint. Data will be attached to complaint inspection document.
 At time of inspection, I spoke with fracing supervisor he stated at time of complaint they were fracing and no unusual activity was taking place.
 Weather conditions: Clear and dry on three sides on side muddy with standing water.
